"I am trying to survive on Newstart with 2 children one of whom has autism. With medical expenses, rising cost of utilities, food, car costs, school fees, school uniforms and supplies, general living expenses. My children don't deserve to live in poverty. My child attends school less than 2 hours per day which makes it impossible for me to work."

"I'm a student, I have a disability and can't currently work. The appallingly low rate of Newstart and Youth Allowance has kept me in a poverty trap for the past 5 years. I don't know if I'll ever be able to catch up to my peers now in terms of secure housing, financial stability or good health."

"As someone who experienced first-hand the necessity of relying on the dole in my 20s, I know how demoralising the experience is. Not only is there stigma towards using welfare, but it is extremely difficult to access. And when you get it, there's not nearly enough to cover basic living expenses while you attend to seeking work. It's only because of the dole I can contribute now. Raise the rate."

"Nowhere sufficient for anyone to live on. We, as pensioners are always subsidising our granddaughter's allowance to enable her to purchase petrol to get to University and medication, etc. She doesn't have enough to pay us any board either, so we also have to carry this cost too."

"I lost my previous job and was on Newstart for three months until I found my current job. Newstart, after rent alone being paid, left me with \$80 per fortnight to cover food and other bills. For three months I could only afford one meal per day, and couldn't pay my bills. I was about to have my power and mobile phone cut off, I was underweight and malnourished when I finally found my current job."
